The record date for the purpose of eligibility to participate and vote at the Meeting, pursuant to Section 182(b) of the Companies Law, 5759-1999, and Regulation 3 of the Companies Regulations (Voting in Writing and Position Notices), 5766-2005, is **Thursday, June 4, 2026**. Shareholders may participate and vote in person or by proxy. A shareholder wishing to vote by proxy shall deposit the power of attorney at the Company's offices or at the designated location for convening the Meeting, no later than 48 hours before the commencement of the Meeting.

The last date for submission of the voting ballot to the Company's registered office is up to four (4) hours before the time of the Meeting. In addition, a shareholder may vote at the Meeting, on the item on the agenda, also through the electronic voting system, up to six (6) hours before the time of convening the Meeting. The last date for submission of position notices from a shareholder to the Company is up to ten (10) days before the date of the Meeting.
